## What we see

Throughout the world, a majority of people do not fully enjoy freedom, civil liberties and political rights. Though civil society is blooming globally and the Sustainable Development Goals promise further improvements, we note some worrisome counterforces:

- ❖ The number of human right defenders and journalists killed because of what they do and say is ever increasing
- ❖ Pressure from authorities and private interest to curtail basic freedoms is increasing
- ❖ Military conflicts increasingly affect civilians, with the number of refugees and internally displaced people at an all-time high of 68 million in 2017
- ❖ Climate change starts to affect many countries and leads to hunger and displacement
- ❖ In Europe the lack of openness and fear for other cultures affects freedom and human rights, also in The Netherlands

## What we believe

Local human rights defenders are instrumental to improve local situations. However, they are fragile when working in isolation. Linking them to an international network in a very visible way, for example by physical accompaniment and through advocacy, makes them stronger and more difficult to ignore or attack.

# What we do

The mandate of PBI Netherlands is to create space for peace and to protect human rights by:

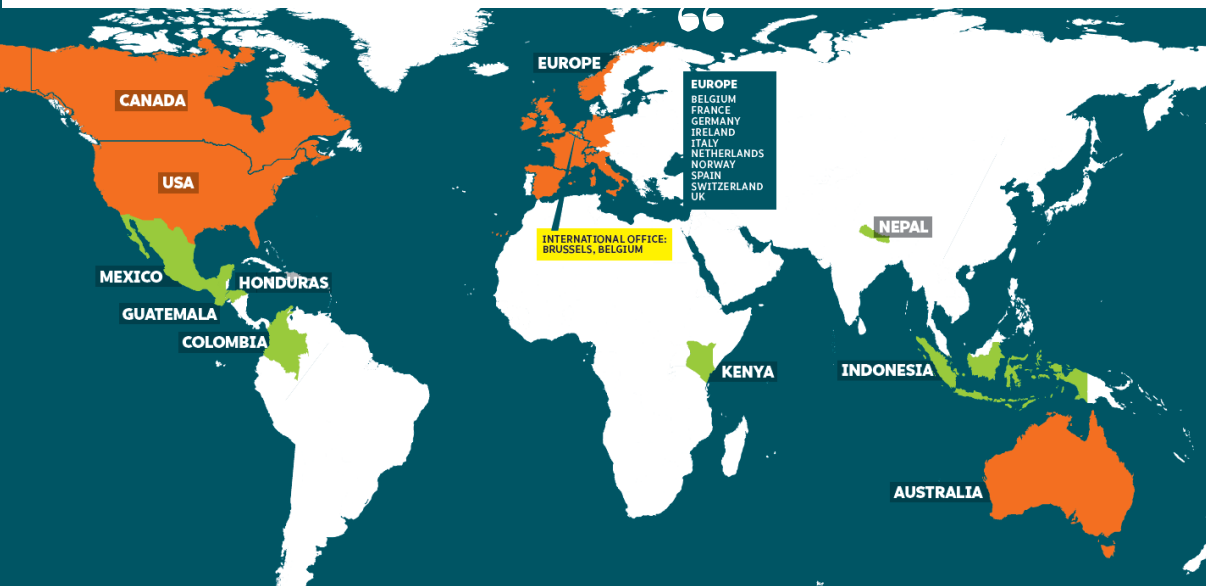
- ❖ providing temporary shelter for human right defenders in the Netherlands
- ❖ raising public awareness for the work of human right defenders by organising speaker tours and film screenings and engage through publications and social media
- ❖ recruiting and training volunteers for PBI's field offices
- ❖ contributing to national and international support networks for activists that need protection through public relations and advocacy work, observing and reporting
- ❖ engaging with Dutch stakeholders involved in peace and human rights work, to share and develop knowledge
- ❖ raising funds for PBI's work in field countries and the Netherlands.

## Shelter City

Partnering with the Utrecht municipality, Justice & Peace, SIM and UAF, we offer temporary shelter to human right defenders through the Shelter City project. During his or her stay we set up meetings with Dutch NGOs and government to enhance their network. To share their stories and engage with an interested crowd, we organise 'human right cafes'.

PBI has been involved in the project since 2015 and will continue to be in the following years.

# Our goals for 2019–mid 2024

PBI is a volunteer organization. In the Netherlands we work with a small paid staff of 2 part time members. This staff coordinates our knowledgeable and enthusiastic teams of country specialists and communications/event organisers.

In the past years we have been successful in providing shelter, hosting events and liaising with relevant parties. Also, we were instrumental in securing a large grant from the Dutch Ministry of Foreign Affairs for PBI's Mexico, Honduras, Colombia and Guatemala field projects. We published and disseminated a toolkit on the protection of woman human right defenders (WHRD's), and undertook a study and organised a symposium on the situation of WHRD's in Egypt, Sudan and other MENA countries.

Unfortunately, we have not been able to grow our organisation as we had planned, thereby not being able to structurally grow in our activities. We feel that, since governmental policies in the Netherlands fully acknowledge that speaking-out and influencing policies is a key strategy to promote sustainable change, the impact of PBI NL could and should be greater. That is why our strategy for the coming years (2019-2023) is to continue our current activities, while also

- ❖ Look for alliances where we complement the work of other organizations and networks
- ❖ Build on relations with former volunteers to facilitate and encourage them to stay active for PBI in other ways
- ❖ Next to the ~30 students and young professionals a year, engage other types of volunteers, such as retired professionals or specialists for specific tasks, especially in the field of communications and fundraising
- ❖ Where relevant seek to recruit more non-Dutch nationals, for example other EU nationals or foreigners (legally) residing in the Netherlands
- ❖ Grow in number and engagement of donors by enhancing our visibility, share more stories and be smarter in combining events with fundraising
